

## Honoring Dr. Ed Johnson



Pastor Edwin Johnson Jr., the Executive Director of the Minnesota Association of Christian Schools (MACS) for many years retired as of September of this school year. He was honored at a special service at his home church

First Baptist Church or Rosemount on October 19 2011.

Dr. Johnson became pastor of First Baptist Church of Rosemount, MN on June 7, 1967. He started the church's first Vacation Bible School and witnessed tremendous growth in the church in his first 5 years as pastor.

Pastor Johnson was instrumental in starting First Baptist Christian School in 1971 as enrollments were accepted from Kindergarten through the 4<sup>th</sup> grade. The school added K4 and 5/6<sup>th</sup> grades in 1972 and junior high and high school were completed by 1974.

It was in 1974 that Pastor

Johnson received his doctorate from Hyles-Anderson College. In 1976, First Baptist School held its first graduation ceremony with 11 graduates in May of that year.

In 1977, Dr. Johnson became associated with MACS as President of the state chapter. Through the years, Johnson became verv interested in legislative issues that impacted our Christian schools. In 1987, Dr. Johnson served on a task force to pass legislation called, "Definition of a School Bill" in the state of MN. That legislation enabled parents to choose private, public or home school options

Dr. Johnson served on the Board of Directors of the American Association of Christian Schools for two terms (1991-1995 and 1999-2002). He was honored to be

asked to pray in the US House of Representatives as their guest chaplain on September 13, 1993 and was a delegate to the National Republican Convention in 1996. Dr. Johnson has served as the Executive Director of the Minnesota Association of Christian Schools for well over 15 years.

#### Legislative Update: Race To the Top (RTT) - Early Learning Challenge State Grant

For the past couple of months, we have been making calls and sending emails to state and federal legislators regarding this issue. Funds are due to be distributed in December and the law will go into effect upon receipt of grants. This law is a part of the Obama Stimulus Package that grants 500 million dollars to states whose Early Education Plans are approved by the US Department of Education. Minnesota stands to receive \$50 million dollars and an additional \$9-11 million if their application is considered one of the best.

The reason for the program is that the federal government believes that early education (intervention from 0-3 years old) will narrow the achievement gap that currently exists between higher and lower income children. There are; however, stipulations in this grant application which allows the federal government to have a direct hand in all private school education as a result of the state accepting the money. Those stipulations include licensing of all preschool programs, national kindergarten entrance testing, teacher licensing, and early learning development standards. These standards will define expectations and developmental milestones that all children should attain by kindergarten entry. Furthermore, these standards must be developmentally, linguistically, and culturally appropriate according to federal standards.

Praise the Lord for MN Congressman John Kline, current chairman of the US House of Representatives Education Committee. His office called the MACS office on Tuesday,

November 15, to let us know what was currently happening. They shared that all attempts to address this issue have failed and they are going directly to the Secretary of Education, Arne Duncan. The office further said that this attempt of federal government intervention is "unprecedented." Congressman Kline's office is determined to try to get a religious exemption instituted on behalf of all private preschools and kindergartens nationwide.

As a result of this progress, and believe me, it is progress, we are asking God's people, who care about the continued autonomy of Christian education, to pray for Congressman Kline's office and for Secretary Duncan – that God would work through these people to protect what we have enjoyed for many years. The success of Christian education is not dependent upon federal government guidelines, money, licensing, or testing. The success of any of our programs is totally dependent upon the truth of God's Word as it is taught, the discipling of our children from godly teachers, the philosophy of our schools being the extension of the Christian home, and the integration of Bible truth throughout all that we teach.

We are at crunch time regarding this legislation and we need the hand of God to protect our schools. Thanks for your prayers on behalf of Christian early education and all private education nationally. –*Alan Hodak*

#### The Process of Accreditation

As you may know, for the past two years, our state Christian school association (MACS) has worked for our accreditation instrument to become state approved. The process was lengthy, but we wanted to make sure that if we were going to work toward accreditation, that the state would look at our accreditation and be in total approval of it. So, last year, the MN Dept. of Ed. approved the American Association of Christian Schools (AACS) accreditation instrument.

As a result of this decision, a number of our schools decided to move ahead with accreditation. Fourth Baptist, Woodcrest Baptist, and First Baptist of Rosemount are working together on the first phase of accreditation (We hope that our other MACS schools will soon follow). This is a huge step for our schools, but we believe it will be very beneficial as it forces us to take a good look at ourselves and our programs. We'd appreciate your prayers on our behalf. —AH
