# The Erosion Explosion

"Liberal (progressive) government expansion equals a further erosion of religious freedom in America." ~Alan J. Hodak

Five years ago, Minnesota jumped on the Early Learning Grant bandwagon and accepted federal grant monies for preschool. Millions of dollars poured into the state to give preschool and daycare aide to low income families. The argument was that the earlier children enter school, the better their achievement resulting in the narrowing of the achievement gap. So far, the focus of "free" preschool for lower income children has been the emphasis as our federal government is pouring billions of dollars of taxpayer money into "free" preschool in our state. Head Start, a government-run preschool program, is the main recipient of federal aid for preschool. At a federal taxpayer cost of \$8,000 per child annually, one must ask, "Is it working?"

After 48 years of our federal government funding the operation of the Head Start program, a Congressional mandated evaluation has been published by the US Department of Health and Human Services (HHS). The report reveals the failure of the Head Start program "to improve the cognitive abilities of children, their access to health care, and the parenting practices of participants." In an article written by Lindsey Burke entitled, "Head Start Fails Poor Children," Mrs. Burke stated the following: "What is particularly alarming is that access to Head Start actually has some negative impacts on enrolled children. In addition to having little to no

impact on the cognitive, social-emotional, health, or parenting practices of its participants, federal researchers reported worse peer relations and lower teacher-assessed math ability for Head Start children." This latest evaluation is important because of its design. The study tracked 5,000 children who were randomly assigned to either a group receiving Head Start services or a group that did not participate in Head Start. It followed



their progression from ages 3 or 4 through the end of third grade, and was a continuation of HHS's Head Start Impact Study, which followed children through the end of first grade. "This design is scientifically rigorous. It allows us to say, without a shadow of a doubt that exposure to Head Start itself results in poorer outcomes for poor children."

The desire of our President is to see preschool funding expanded. The liberal agenda is to one day make universal preschool mandated and paid for by our government. Minnesota's own Governor Dayton wanted to expand aid for average wage earners spending our state's

budget surplus on preschool and daycare programs. While this was rejected by our state House, mandated preschool will surely be on the forefront of the liberal agenda for years to come.

As a result of government-mandated preschool, parental choice may be minimized further eroding our right to choose whether or not we want our children to be in a preschool program at all or what kind of a program we might want to select. The addition of a "free" price tag takes away our freedom to choose.

Another freedom that is being eroded is in the area of religious freedom. With the legalization of gay marriage, our nation is confronted with a number of new challenges with regard to religious rights. According to Title 9 discrimination laws, court cases are being brought which are challenging private Christian colleges and universities with regard to their admissions policies. Can private religious schools prevent gay students from attending (or living in their dorms) when the schools are accepting government Pell grants and other monies? What happens to private Christian organizations who write policies which prevent or eliminate certain individuals from participation based on stated biblical positions and policies? Can the Christian businessman or woman refuse to perform services based on conscience? Can a pastor refuse to perform a same-sex marriage in his church when he is licensed by the state to perform marriages?

Didn't think this would happen so fast, did you? Neither did I, but we must understand that the current liberal agenda is on the fast track. These issues and many others will be decided for us by a government that is actively minimizing the value of religious freedom in our nation. As the gay rights issues are changing many of the laws related to discrimination and civil rights, we find that the devaluation of religion in our culture seems to be the by-product. If the government forces universal preschool upon us, everyone will run to "free" and the options of private, religious programs may not be available too much longer. The truth is that these schools will just go out of business, because

there is a "free" alternative.

Representative Paul R. Labrador (ID) has introduced legislation, which currently has 151 co-sponsors including MN Representatives Kline and Emmer. The legislation is called the First Amendment Defense Act (FADA-H.R. 2802). The bill was written to protect religious liberty against newly created understandings of fundamental civil rights. FADA would prevent our own federal government from discriminating against individuals or organizations that believe that marriage is the union of one man and one woman. Specifically, the bill would prevent the government from denying tax-exempt status, a federal grant or contract, or employment based on a person's or group's beliefs in

natural traditional marriage. The bill allows for freedom o f conscience, which is the main freedom that o u r government seems to be intent upon taking away. Currently, FADA is sitting in



Oversight and Government Reform Committee chaired by Rep. Jason Chaffetz from Utah. There is a very good chance that this bill will go on to the House of Representatives after a Legislative Hearing on the bill. At the hearing, amendments may be introduced on the specific bill and then the final version of that bill would go to the floor for a discussion and a potential vote.

What is freedom of conscience?

Freedom of conscience is the right given to doctors to decide not to perform abortions. If their conscience dictates that they cannot perform a procedure which they believe is



wrong, then they are not forced to perform it based upon that very conscience. Our liberal government wants to change that.

They want us to "change our faith practice" in matters of conscience. Whether it is requiring a flower shop owner to provide flowers for a gay

marriage, a pastor refusing to perform a gay marriage ceremony, or a private, religious college denying admission for a gay student, government wants us to change the expression of <u>our</u> faith practice.

It was James Madison who wrote, "Conscience is the most sacred of all property" (Madison).<sup>2</sup> This founding truth in America is rooted in the First Amendment which states: "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof..." Government seems to be forgetting this part of the First Amendment and so has most of America!

What will the living out of our faith look like in a few years if we don't consider the ramifications of a government determined to change the way we look at religious freedom and our expression of it? "Please remember that preeminent to all the rights given to us by our Constitution and Bill of Rights is religious freedom. It was the reason our founders came to this nation. It is the pillar and the chief core value of our democracy and it is an integral part of our American identity." (Sen. Oren Hatch (Utah) in a speech to AACS representatives on 9/15/15).

The key to victory in both the battle for preschool choice and religious rights is an educated electorate. We must stand against free universal preschool by placing into our legislature folks who understand the value of choice for the education of our children. Our families must remain consistent examples of what a stable and loving traditional family should look like, a kind but truthful rejection of the notion that consenting adults should be able to do anything they want to do, and a continued witness of the truth as we live out our faith. To squash the "living out" of our faith will stifle the "right of conscience" we have enjoyed in our country for the duration of our history. We must again be proactive in our fight for maintaining our religious liberties. Please call your MN Representative to encourage him to vote for FADA. The left would say that this is a "hate bill." That is simply not true. Should you hear that kind of language, ask folks to please educate themselves by taking the time to read the bill in its entirety. 








# Woodcrest Teacher Named MACS Teacher of the Year




